**ARTICLE X.****Indemnification of Directors****and Officers**

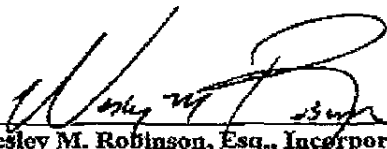
