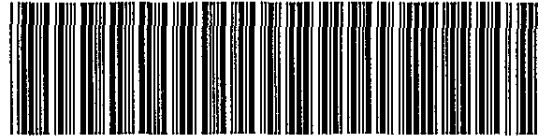



**ARTICLES OF INCORPORATION
OF
*Got Floors?, Inc.***

ARTICLE I. NAME

The name of the corporation is:

Its business shall be conducted in the United States and its possessions and in all foreign countries, wherever necessary or convenient.






