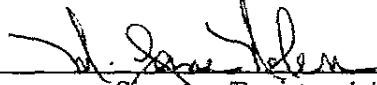

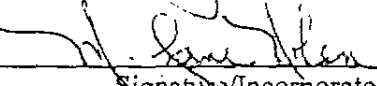

this 4<sup>th</sup> day of December, 2003.

Article III
