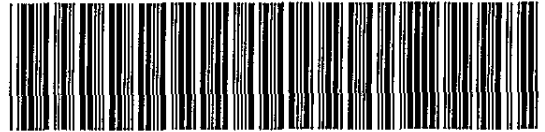

Articles of Incorporation

of

SCOTTY BOWMAN PROMOTIONAL SERVICES, INC.

The undersigned Incorporator of these Articles of Incorporation, a natural person competent to contract, pursuant to the requirements of Florida law, in particular Florida Statutes Section 607.1801, hereby files with the Florida Department of State these Articles of Incorporation, for the purpose of domestication of **SCOTTY BOWMAN PROMOTIONAL SERVICES, INC.** under the laws of the State of Florida.

ARTICLE I

NAME & ADDRESS: The name of this Corporation is **SCOTTY BOWMAN PROMOTIONAL SERVICES, INC.** The Corporation's business and mailing address shall be:

ARTICLE II

CORPORATE PURPOSES: The corporate purpose is to engage in any lawful acts, activities or businesses for which corporations may be organized under the laws of the State of Florida or the United States.

ARTICLE III

CAPITAL STOCK: The shares of stock of this Corporation shall consist of only one class. The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is: Two Hundred (200) shares of Common Stock having no par value.

Pre-emptive rights will be granted to shareholders to purchase pro-rata any additional shares

of common stock authorized to be issued hereunder.

ARTICLE IV

TERM OF EXISTENCE: This Corporation is to exist perpetually.

ARTICLE V

ADDRESS: The initial street address of the registered office of this Corporation in the State of Florida is: 1800 Second Street, Suite 870, Sarasota, Florida 34236. The Board of Directors may from time to time move the registered office to any other address in Florida. The initial registered agent at aforesaid address shall be IRA STEWART WIESNER, ESQ.

ARTICLE VI

INITIAL DIRECTORS: All Corporate powers shall be exercised by or under the authority of, and the business and affairs of the corporation managed under the direction of its Board of Directors, subject to any limitations set forth in these Articles of Incorporation. This corporation shall have two Directors, initially. The number of Directors may be modified from time to time by By-Laws adopted by the Shareholders.

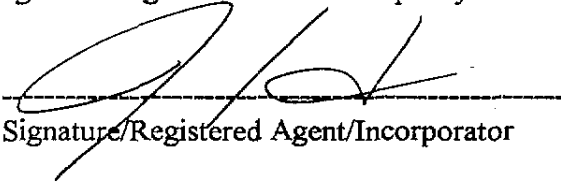
ARTICLE VIII
