FRITICLE I. NAME AND ADDRESS

The name and address of this corporation shall be WFSSS INVESTMENT CORPORATION, 6420 SUN COUNTRY DRIVE, NEW PORT RICHEY, FL 34653.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State. This corporation's duration shall be perpetual.

ARTICLE III. PURPOSE

This corporation is being organized for the purpose of real estate investment, etc., and any and all business activities permitted under the laws of Florida and the United States of America.
