The undersigned, acting as Incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

1. Name – The name of this corporation is Coast Line Insurance, Inc.
2. Duration – The period of its duration is perpetual.
3. Purpose – The purpose of the corporation is to engage in any activities or business permitted under the laws of the United States and Florida.
4. Capital Stock – The Corporation is authorized to issue 135,000 shares, all of one class, at \$1.00 par value.

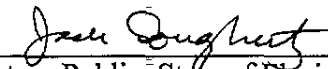
