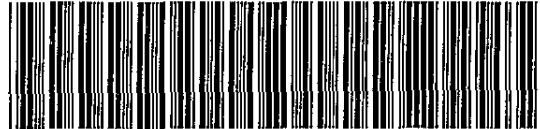

**ARTICLES OF INCORPORATION
OF
BENNETT'S GLASS CO., Inc.**

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned being natural persons, do hereby act as an incorporators in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation under the Florida Business Corporation Act.

ARTICLE I

The name of the corporation ("corporation") is:

Bennett's Glass Co., Inc.

ARTICLE II

The address of the principal office of the corporation is 831 Goldkist Boulevard, Live Oak, FL 32064 and its mailing address is PO BOX 486, Live Oak, FL 32064

ARTICLE III

The Maximum number of shares the corporation is authorized to issue is ten thousand (10,000) all of which shall be common shares.
