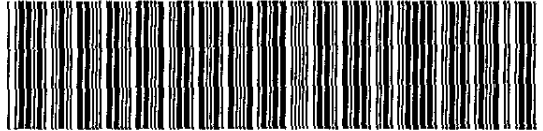

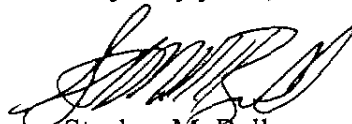

The undersigned, for the purposes of forming a corporation under the Florida Corporation Act, Florida Statutes 607, hereby adopts the following articles of incorporation.

Article I

Name. The name of this Corporation is Crom Engineering and Construction Services, Inc.

ARTICLE II - Principal Office

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

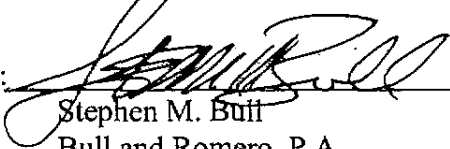
