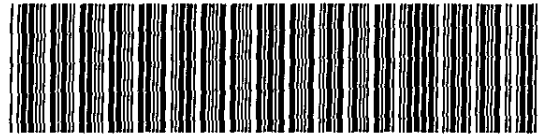

ARTICLES OF INCORPORATION

OF

SHAD HARRISON FLOORING, INC.

A Florida Corporation

ARTICLE I NAME

The name of the Corporation is: SHAD HARRISON FLOORING, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE
