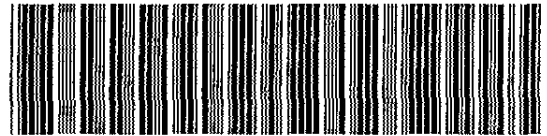

ARTICLE X




