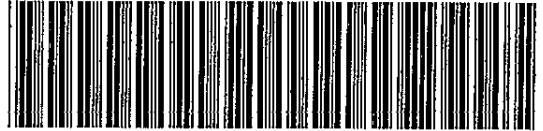

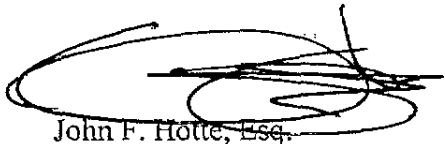

ARTICLES OF INCORPORATION
OF
EURO BREAD & CAFE OF LAS OLAS, INC.

The undersigned incorporator hereby forms a corporation, under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the Corporation shall be:

EURO BREAD & CAFE OF LAS OLAS, INC.

The address of the principal office of this Corporation shall be 2400 East Commercial Boulevard, Suite 826, Fort Lauderdale, Florida 33308.

ARTICLE II. NATURE OF BUSINESS
