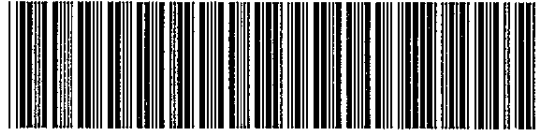

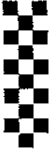


Dear Stacy:


