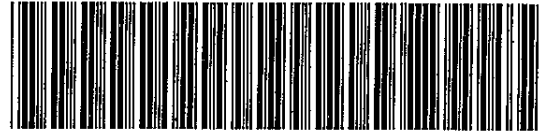

OF EURODEC INC.**

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation shall be EURODEC INC. The address of the principal office of this corporation shall be 636 West Yale Street, Orlando, Florida 32804, and the mailing address of the corporation shall be the same.

ARTICLE II: NATURE OF BUSINESS AND PURPOSE


