ARTICLE I.

NAME

The name of this corporation is AV General Partner Corp.

ARTICLE II.

PRINCIPAL OFFICE

COMMENCEMENT OF EXISTENCE

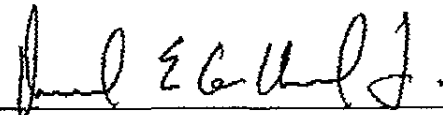
