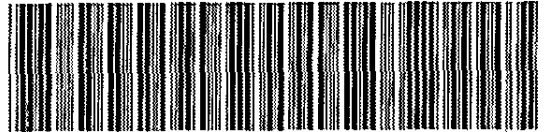

ARTICLE I - CORPORATE NAME

The name of this Corporation shall be:

KAYE & ASSOCIATES, P.A.

ARTICLE II - NATURE OF CORPORATE BUSINESS

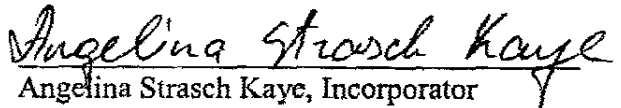
