The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE ONE

The Corporation name is **DAVID JASKOWIAK TILE, INC.**

ARTICLE TWO DURATION

The Corporation shall exist in perpetuity.

ARTICLES THREE PURPOSE
