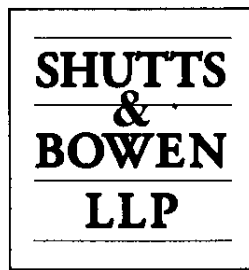

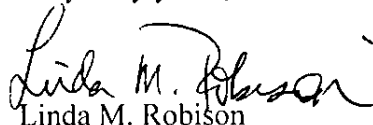

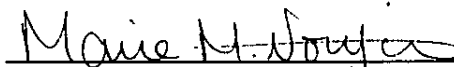
3. Article V of the Articles of Incorporation of the Corporation is hereby amended to change the registered address of the Corporation's registered agent to read as follows:
