ARTICLES OF INCORPORATION

The undersigned incorporator hereby files these Articles of Incorporation in order to form a corporation under the laws of the State of Florida.

ARTICLE I Name and Principal Office of Corporation

The name of this Corporation shall be KINETIC KIDS, INC. The initial mailing address of the Corporation shall be 1000 West Avenue, #1516, Miami Beach, FL 33139.
