I, the undersigned, being of legal age and natural person, do hereby subscribe to, acknowledge and file the following Articles of incorporation for the purpose of creating a corporation under the laws of the state of Florida.

ARTICLE I NAME

The name of this corporation is 46 & 7, INC.

ARTICLE II PURPOSE

This corporation is organized for the purpose of transacting any or all-lawful business.

ARTICLE III

This corporation shall be authorized to issue 1,000 shares of capital stock, at a par value of \$1.00 per share.
