ARTICLES OF INCORPORATION OF P.C. CAMPOS ENTERPRISES, INC.

<u>ARTICLE I - NAME AND MAILING ADDRESS</u>

The name of this corporation is P.C. Campos Enterprises, Inc. The mailing address is $5617 - 5^{th}$ Street E., Bradenton, Fl. 34203.


