

The undersigned Incorporator hereby adopts the following Articles of Incorporation ("Articles") for the purpose of forming a profit corporation under the Florida Business Corporation Act.

ARTICLE I  
CORPORATE NAME AND PRINCIPAL OFFICE

The name of the Corporation shall be **Gulfcoast Cypress Center, Inc.**, and the address of the principal office of the Corporation, which is also its mailing address, is 2960 Immokalee Road, Building A, Naples, Florida 34110.

ARTICLE II  
PURPOSE

The purpose for which the Corporation is formed is to engage in any activity within the purposes for which corporations may be formed under the Florida Business Corporation Act.


