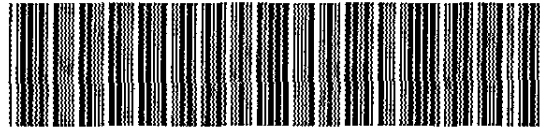

**ARTICLES OF INCORPORATION
OF
CERTIFIED PLUMBING, SEWER, & DRAIN, INC.**

The undersigned, who desires to form a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I-NAME

The name of this corporation is Certified Plumbing, Sewer & Drain, Inc.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation with the Department of State.

ARTICLE III-PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may after be amended.
