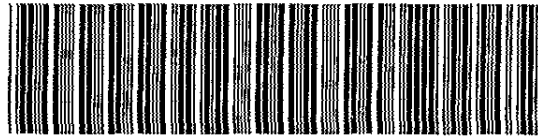

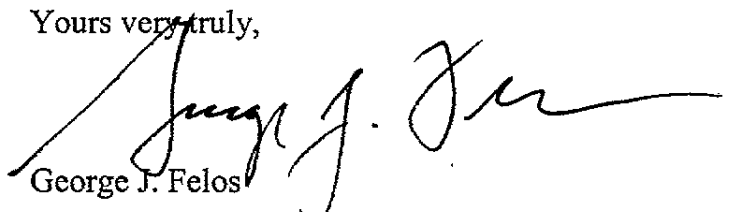

The undersigned subscriber hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name shall be AVA & GEORGE, INC.

ARTICLE II - DIRECTOR

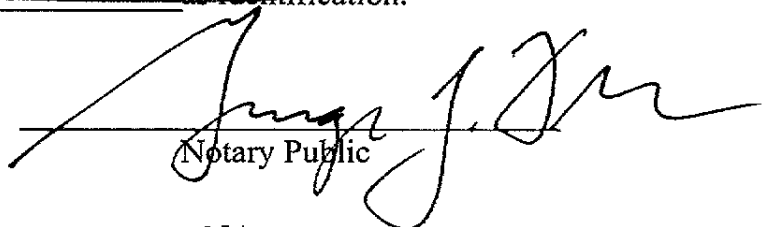

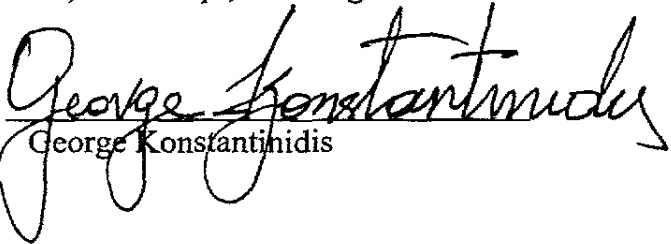
