The name of this corporation shall be:

## ARTICLE XI



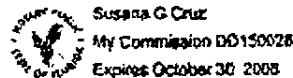


