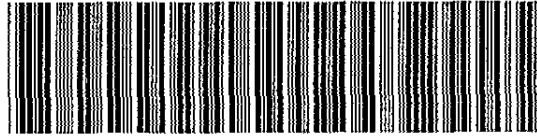

1. The name of the corporation is L.R.S. Construction and Remodeling, Inc.

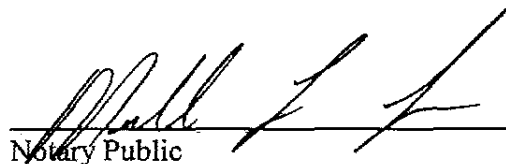
