ARTICLES OF INCORPORATION  
OF


ARTICLE VII - BY LAWS

ARTICLE IX - AMENDMENT

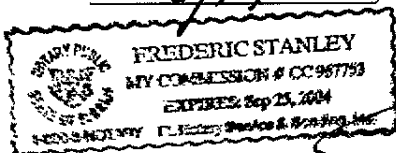


