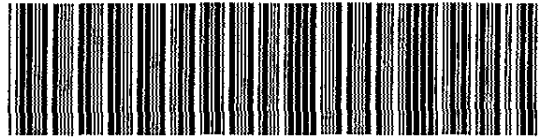

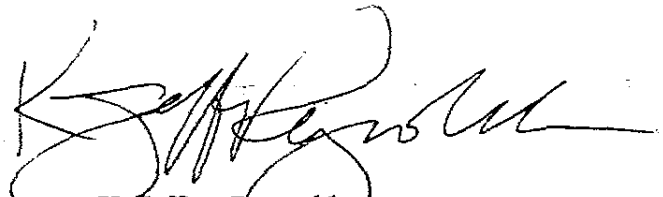

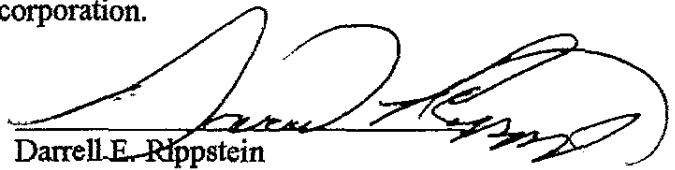

The corporation intends to elect to be treated as an S Corporation under the Internal Revenue Code.

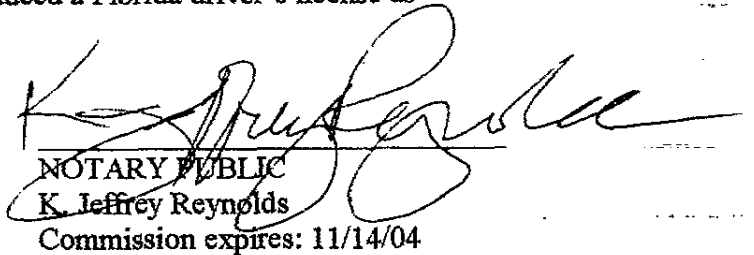
