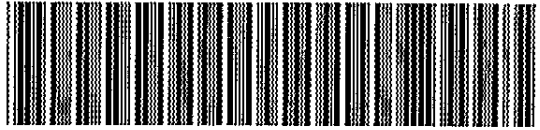

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME AND ADDRESS

The name of the corporation is Montalvo Lawn & Landscape Services, Inc.

ARTICLE II. NATURE OF BUSINESS




