# ARTICLES OF INCORPORATION

## OF

# JAMES B. SEYMORE, JR., P.A.

The undersigned, desiring to form a professional service corporation under Chapter 607, the Florida General Corporation Act, and Chapter 621, the Professional Service Corporation Act, does hereby certify:

#### ARTICLE 1

The name of ther corporation (which is hereinafter called the ("Corporation") shall be James B. Seymore, Jr., P.A., and its principal office and mailing address shall be 33 East Georgie Street, Santa Rosa Beach, Florida 32459.

#### ARTICLE 2

The purposes for which the Corporation is formed are:

- (a) To engage in every aspect of the practice of real estate sales.
- (b) To engage in and render professional services only through its officers, agents and employees who shall be duly licensed and authorized within the State of Florida to act as a real estate salesperson, and to engage in no other business other than the rendition of such professional services.
- (c) To invest its funds in real estate, mortgages, stocks, bonds and any other type of investments, and to own real and personal property.
- (d) To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto, as permitted under the laws of the State of Florida.

#### ARTICLE 3

The Corporation shall have perpetual existence.

#### ARTICLE 4

The aggregate number of shares which the corporation is authorized to issue is One Thousand (1,000) shares of common stock with a par value of One Dollar per share. Shares of the Corporation's

stock shall be issued only to duly licensed persons authorized within the State of Florida to act as real estate salespersons.

#### ARTICLE 5

The street address of the initial registered office of the Corporation is 35 Clayton Lane, Santa Rosa Beach, Florida 32459, and the name of the initial registered agent of the Corporation at that address is Mary K. Kraemer.

## ARTICLE 6

The Board of Directors of the Corporation shall conduct the affairs of the Corporation and shall consist of one or more directors, the exact number of which shall be the number of directors from time to time fixed by the Board of Directors or the shareholders in accordance with the Bylaws of the Corporation. The name and address of the initial Director of the Corporation, who shall hold office until his successor(s) have been duly elected and qualified, are as follows:

#### **ARTICLE 7**

The name and address of the incorporator signing these Article of Incorporation is James B. Seymore, Jr.

#### ARTICLE 8

These Articles of Incorporation may be amended in the manner provided by law. Amendments may be proposed by the Board of Directors to the shareholders, and adopted upon the vote of a majority of the shareholders entitled to vote. The shareholders may amend the Articles of Incorporation without an act of the Directors, and all of the Directors and all of the shareholders eligible to vote may sign a written statement manifesting their intention that an amendment to the Articles of Incorporation be adopted.
