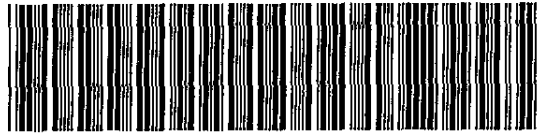

The name of this Corporation is Merchant Consulting Service, Inc.

ARTICLE VIII



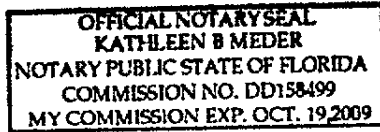


