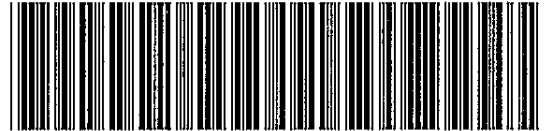

The undersigned, for the purpose of forming a corporation under the laws of the State of Florida under the corporation name of **SPENDING TIME CORP**, does hereby set forth and declare:

ARTICLE I

The name of the corporation shall be **SPENDING TIME CORP**.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The authorized capital stock which the corporation may issued shall be **ONE THOUSAND (1000)** shares of \$1.00 per value common stock, which shall be nonassessable and held, sold, and paid for at such time and in such manner as the Board of Directors may from to time determine.

ARTICLE IV

The corporation shall commence business on filing with the Secretary of State.

ARTICLE V

The corporation shall have perpetual existence, except that the same may be dissolved, as provided by law.
