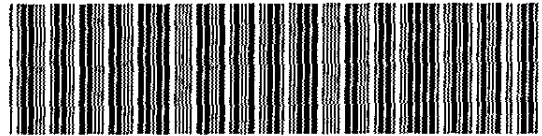

ARTICLE I - NAME

The name of this Corporation is SROC, INC., and the principal business and mailing address of the Corporation is 12412 San Jose Boulevard, Suite 104, Jacksonville, Florida 32223.

ARTICLE II - COMMENCEMENT AND DURATION

Pursuant to Section 607.0203, Florida Statutes, this Corporation shall commence upon the date of execution of these Articles of Incorporation. This Corporation shall have perpetual existence.


