# ARTICLES OF INCORPORATION OF GIBSON COMMERCIAL DEVELOPMENT, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

#### ARTICLE I NAME

The name of the corporation is Gibson Commercial Development, Inc. (hereinafter called the "Corporation").
