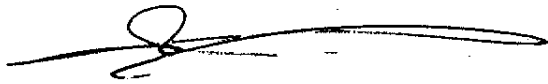

The undersigned, incorporator of a corporation for profit under the Florida General Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation is: RIDER GROUP INC.

ARTICLE II ADDRESS

The initial mailing address of the principal office of this corporation in the State of Florida is 1128 Russell Drive, Highland Beach, Florida 33487. The Board of Directors may from time to time move the principal office to any other address in Florida.

ARTICLE III NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be the transaction of any or all lawful business for which corporations may be incorporated under the Laws of the State of Florida.

ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue seven thousand five hundred (7,500) shares of common stock. For the purpose of franchise, transfer, and similar state and federal taxes only, said stock shall have a par value of one (\$1.00) per share.

ARTICLE V DIRECTORS

The corporation shall have no less than one (1) nor more than four (4) directors. The number of directors may be increased or diminished from time to time by the by-laws adopted by the stockholders.

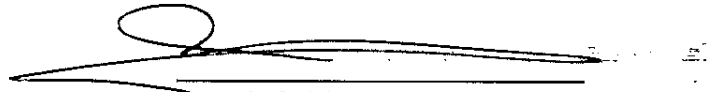
ARTICLE VIII EFFECTIVE DATE

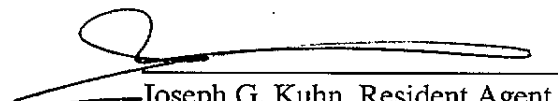
