ARTICLE I

The name of this corporation is RANDY M. CISNE, INC. Its principal place of business is P.O. Box 50726, Jacksonville Beach, FL 32240, and its mailing address is P.O. Drawer 511447, Punta Gorda, FL 33951-1447.

ARTICLE II

This corporation shall have perpetual existence or shall exist until dissolved by operation of law.

ARTICLE III

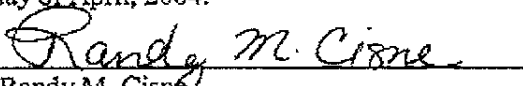
