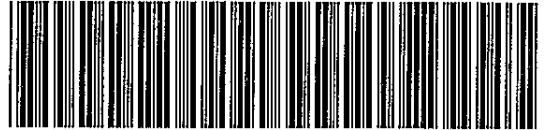

The name of this corporation shall be: WOTL, INC.

The principal office and mailing address of the corporation is 3100 N. W. Boca Raton Blvd., #224, Boca Raton, FL 33431.



ARTICLE IX - INDEMNIFICATION


The corporation shall indemnify any officer or director, or former officer or director, to the full extent permitted by law.

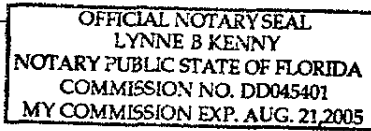
