





ARTICLES OF INCORPORATION OF WOTL, INC.



ARTICLE I - NAME

The name of this corporation shall be: WOTL, INC.

ARTICLE II - DURATION

This corporation shall commence its existence on the date of execution and acknowledgment of these Articles of Incorporation and shall exist perpetually unless sooner dissolved according to law.
