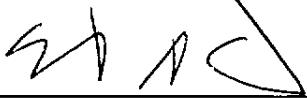

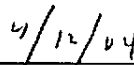

COMMENCEMENT OF CORPORATE EXISTENCE AND BUSINESS

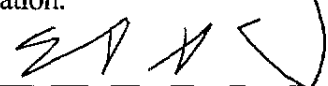

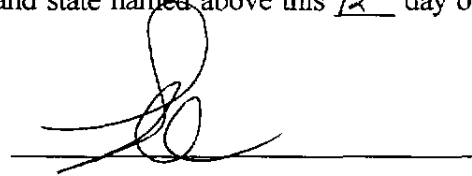
