



ARTICLES OF INCORPORATION OF CENTRAL FLORIDA FLOORS DISTRIBUTORS, INC.

ARTICLE I

<u>Name</u>

The name of the corporation is CENTRAL FLORIDA FLOORS DISTRIBUTORS, INC.

ARTICLE II

General Nature of Business
