The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I . Name

Section 1.1. Name. The name of this corporation shall be Cedar River Seafood & Oyster Bar of Middleburg, Inc.

Article II Principal Office and Mailing Address

<u>Section 2.1. Principal Office and Mailing Address.</u> The principal place of business and mailing address of this corporation shall be 1975 Salt Myrtle Lane, Orange Park, Florida 32003.

- <u>Section 3.1</u>. <u>Capital Stock</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of common stock having a par value of \$0.10 per share.

The approval of the shareholders holding sixty percent (60%) or more of the capital stock of this corporation eligible to vote to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.
