SECOND ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF APPSSURANCE, INC.

Pursuant to the provisions of the Florida General Corporation Act and Florida law, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the Corporation is: APPSSURANCE, INC.
- 2. The amendments adopted are as follows:

Article III Purpose is hereby amended by deleting "Business Consulting" and inserting in its place and stead "Business Consulting and to perform any and all acts that lawfully may be performed by corporations organized for profit under Florida Law."
