

# ARTICLES OF INCORPORATION INV. 19 P. 212

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation for profit under the laws of the State of Florida.

## ARTICLE I. NAME

The name of this corporation is AQUACURES, INC.

ARTICLE II. NATURE OF CORPORATE BUSINESS
