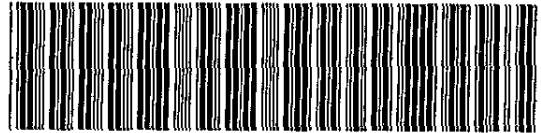

The name of the Corporation is **Iovino Inc**, and the principle place of business of the corporation shall be: 3824 101st Ter N., Pinellas Park, FL 33782-3937.

ARTICLE TWO - NATURE OF BUSINESS

This corporation may engage in any activity or business that is permitted under the laws of the United States and of the State of Florida. ARTICLE THREE - CAPITAL STOCK






