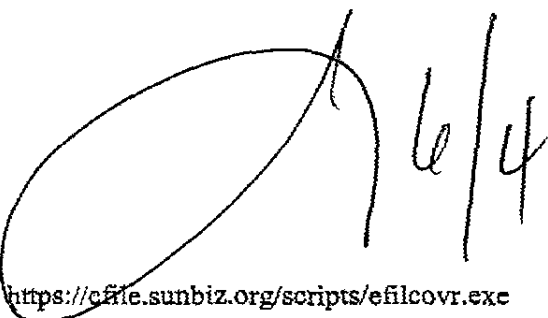

Pre-emptive Rights

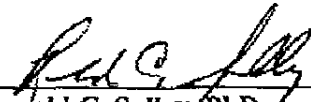
