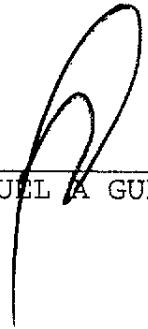

ARTICLE I

The name of the Corporation is:

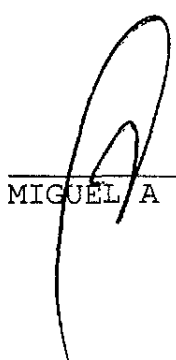
