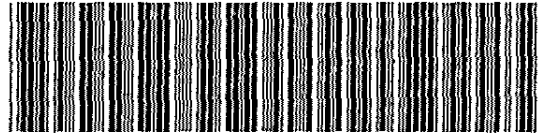

ARTICLES OF INCORPORATION
OF

THE UNDERSIGNED INCORPORATOR (S), FOR THE PURPOSE OF FORMING A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, HEREBY ADOPT (S) THE FOLLOWING ARTICLES OF INCORPORATION.

ARTICLE I

The name of the corporation shall be:
BRITO SEWING MACHINES, CORP.

ARTICLE II

The general nature of the business and the objects and purpose proposed to be transacted and carried on, are to do any and all of the things lawful under the laws of the State of Florida, and any other State, and to the same extent as natural person might do.

- A. To buy, sell market, distribute items of every type and nature, including but not limited to any marketable product or item whether produced by the corporation or by others.
- B.
