





ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of this corporation is <u>CouponSurplus.com</u>, <u>Inc.</u> and its principal place of business shall be located at <u>9300 5th Street N. St. Petersburg</u>, <u>FL. 33702</u>.

ARTICLE II - DURATION
