Articles of Incomposition of CAC CREDIT CONTROL CORP.

The undersigned incorporator hereby forms a corporation under the laws of the State of Florida:

Afficie I. CORPORATE NAME

The name of the corporation is: CLC CREDIT CONTROL CORF.

Article III. CAPITAL STOCK

The aggregate number at shares of stock that this Corporation is authorized to issue and have outstanding at any one time is One Hundred Thousand (100,000) shares of common stock having a par value of \$.001 per share.
