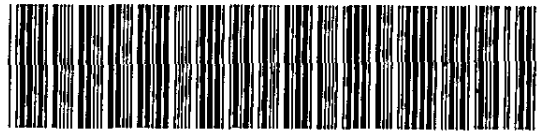

OF

**ARTICLE I- NAME**

The name of this corporation is **JOHN S. RIZZO PAINTING, INC.**
