# ARTICLES OF INCORPORATION OF ARCH PROPERTIES CORP.

I, the undersigned, for the purposes of forming a corporation for profit pursuant to the laws of the State of Florida, do hereby make, subscribe, acknowledge and file the following Articles of Incorporation:

### ARTICLE I - CORPORATE NAME
